BERTHING INDEMNITY

BARBADOS

The Undersigned hereby covenants with Port St Charles Development Limited a company incorporated and registered under the provisions of the Companies Act Cap 308 of the Laws of Barbados and accorded Company Number 7718 whose Registered Office is situate at Heywoods in the parish of Saint Peter in Barbados, (hereinafter called Port St. Charles) in consideration of Port St. Charles registering the yacht described in the schedule hereto for the purposes of entering the Marina and using the facilities therein to indemnify and keep indemnified Port St. Charles Development Limited, Port St Charles Common Services Limited and the owners of all yachts authorized to use the marina and the owners for the time being all properties adjoining the marina in respect of:-

- 1. All actions proceedings cost claims and demands which may be made by any persons in respect of damage suffered by them caused by the said yacht while in the Marina or in the course of entering or exiting the Marina.
- 2. The cost of removing all substances discharging from, thrown overboard or otherwise originating from the said yacht is in the marina or in the marine area including the cost of cleaning and making good all damage which such substance caused or may cause to the marina, adjoining properties or to the natural marine growths in the Marina or Marine Area.
- 3. In respect of any claim proceedings demand or prosecution which may be brought by the Authorities in respect of any action deed relating to the said yacht or any member of the crew of such yacht or any person for the time being on board of the said yacht.
- 4. All actions proceedings costs claims and demands which may be made by any person in respect of damage suffered by a breach of the Port St. Charles Marina Regulations 2018 by the said yacht or any member of the crew of such yacht or any person for the time being on board of the said yacht.

For the purposes of this indemnity the words 'Marina' and 'Marine Area' shall have the same meaning as may from time to time be ascribed thereto in the Port St. Charles Marina Regulations 2018. By the execution of this indemnity the undersigned:warrants that:-

the undersigned is the owner of the said yacht

that the undersigned has the authority to execute the same, and authorizes Port St. Charles to seize and impound the said yacht until Port St Charles is satisfied that the claim in question or breach of the Marina Regulations or property covenants has been adequately resolved within 7 days and thereafter to sell the yacht at local auction with 14 days notice and to pay any excess over the claims and cost to the yacht owner. The yacht owner affirms Port St. Charles will have no responsibility or liability for any damage to the boat or its contents during this process and that the price achieved at the auction may not be representative of its true value but that he undertakes these risks and losses willfully by requesting berthing at Port St. Charles and agreeing to obey all of the Marina Regulations and property covenants.
